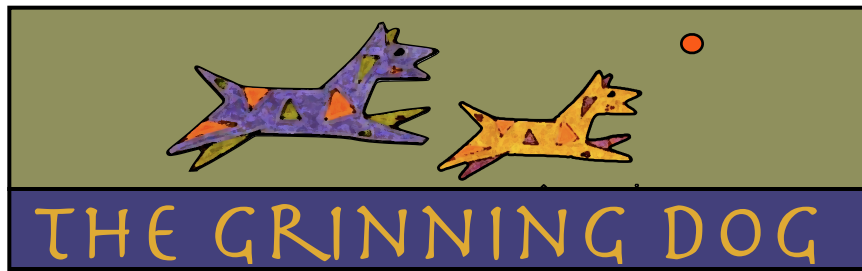


**This is a Liability Release and Contract between The Grinning Dog, LLC ( and/or Alison D. Smith) and the pet owner whose signature and initials appear below. Please initial each statement you agree with and sign at the bottom of the page.**

- I certify that I am the owner of this pet. I hereby grant permission to this pet boarding establishment to act on my behalf, and in the pet's best interest, by obtaining **veterinary care at my expense**, if deemed necessary, for illness or injury. I further agree to pay for all veterinary and other necessary services incurred by and for my pet during its stay at this facility. \_\_\_\_\_
- This boarding facility agrees to exercise all due and reasonable care to prevent injury or illness to my pet. However, in the event of illness or injury, the owner and employees of this facility shall **not be held personally liable for such illness or injury**. \_\_\_\_\_
- I agree to **pay all costs** for any property damage or personal injury caused by my pet during its stay. I agree to pay all charges on the day of pick-up of my pet and I understand that my pet may not leave the premises until all charges are paid in full. \_\_\_\_\_
- I understand that any **animal left for thirty days beyond the date of pick-up** may be sold or disposed of at the discretion of the kennel owner. \_\_\_\_\_
- I have discussed with the kennel owner or employee regarding letting my dog out to play in one of the **play areas** on the premises and have been warned of the **possibility of my pet escaping** either by digging under or scaling the fence. I hereby give permission for my dog to be let outside to exercise in the play areas. \_\_\_\_\_
- I have discussed with the kennel owner or employee regarding letting my dog run loose on **unleashed dog walks** and have been warned of the **possibility of my dog running away, meeting and being injured by wild animals, or drowning in the ponds**. I hereby give permission for my dog to be unleashed \_\_\_\_\_
- I have discussed with the kennel owner or employee regarding letting my dog **play with other dogs** and have been warned of the **possibility of injury or death** resulting from dog fights, accidents, disease or parasites. I hereby give permission for my dog to interact with other dogs. \_\_\_\_\_
